Consignment of Inventory: The exhibitor (identified as the Business Name & Individual Name above) wishes to sell their inventory, listed on the attached Inventory Worksheet, at The Eclectic Experience (heretofore referred to as the event) being promoted by Digital Documents, LLC and its subsidiary L & K Productions (heretofore referred to as L & K Productions). The term of this consignment agreement shall be in affective from July 24th, 2010 until August 1st, 2010 and the exhibitor will not ask for return of their inventory prior to Sunday, August 1st, 2010 unless this agreement is breached by L & K Productions.

Promotion: L & K Productions shall use its best efforts to promote, display and sell the exhibitor's inventory. The exhibitor will label each of their inventory items with their vendor ID provided to them by L & K Productions. L & K Productions shall clearly identify the exhibitor's name with all inventory. L & K Productions will make every attempt to sell the exhibitor's inventory and will not accept less than the retail price for each inventory item established by the exhibitor and documented on the attached "Inventory Worksheet".

Commission & Payment: For each inventory item sold, L & K Productions will retain 30% of the retail purchase price which the exhibitor listed on the Inventory Worksheet. L & K Productions will email the exhibitor the daily sales of their inventory within 12 hours after the close of the event each day. If the exhibitor does not have email no daily sales reports will be sent. L & K Productions will pay the exhibitor within 10 days after the close of the event. Included with the payment will be the exhibitor's sales for the entire event.

Inventory Drop Off, Pick Up & Duration: Exhibitor will drop off their inventory for sale during the event from 1:00 pm to 8:00 pm on Friday, July 23rd, 2010 at the event location. If the exhibitor is not able to drop off their inventory during this time the exhibitor should contact L & K Productions for other delivery options. The exhibitor and L & K Productions will count and agree on the inventory being dropped off by the exhibitor and received by L & K Productions and document this agreement by signing and dating an Inventory Worksheet.

The exhibitor shall pick up any unsold inventory from 6:00 pm to 8:00 pm on Sunday, August 1st, 2010. If the exhibitor is not able to pick up their inventory during this time, L & K Productions will ship the inventory to the exhibitor and subtract the shipping costs from the exhibitor's commission. The exhibitor and L & K Productions will count and agree on the inventory being returned to the exhibitor from L & K Productions and document this agreement by signing and dating an Inventory Worksheet.

Copyright & Security Interest: Title to the inventory shall remain in the exhibitor's name until the exhibitor has been paid in full or picked up the inventory. Upon payment, title then passes to the purchaser. The exhibitor reserves all copyrights to the inventory, the reproduction of the inventory and in every use the exhibitor shall be acknowledged as the creator and copyright owner of the artwork. L & K Productions shall take all steps necessary to insure that the exhibitor's copyright in the consigned inventory is protected in the exhibitor's name. The inventory shall not be subject to claims by L & K Production's creditors. L & K Productions acknowledges that is has no right to and shall not pledge or encumber any inventory in its possession not incur any charge or obligation for which the exhibitor may be liable.
